ARTICLES OF INCORPORATION

SRI VENKATESWARA TEMPLE (PITTSBURGH)

In compliance with the requirements of the Nonprofit Corporation Law of the Commonwealth of Pennsylvania, approved November 15, 1972, being Act No. 271 (15 Pa S. § 7316), the undersigned, all of whom are of full age, desiring to form a nonprofit corporation, do hereby certify:

1. The name of the corporation is Sri Venkateswara Temple (Pittsburgh).
2. The location and post-office address of its initial registered office in this Commonwealth is 1620 Branning Road, Pittsburgh, Allegheny County, Pennsylvania 15235.
3. The corporation does not contemplate pecuniary gain or profit, incidental or otherwise, to its members. The purpose of its organization is to establish, build and operate a traditional style Hindu Temple dedicated to Sri Venkateswara in the County of Allegheny, or any county contiguous thereto, for the exclusive purpose of providing a place of worship for its members, and of promoting the religious, spiritual, cultural, civic, educational and social improvement of its members and communicants.

4. The Corporation shall have perpetual existence.

 6. The Corporation is organized on a nonstock basis and shall have no authority to issue shares of capital stock.
 7. The Corporation is organized exclusively for charitable and educational purposes as defined and limited by Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), including, but not limited to:
 - a. The purposes set forth in paragraph 3 hereof.
 - b. The making of distributions for such purposes to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Revenue Law).
- No members of the Corporation shall receive any pecuniary gain or profit, incidental or otherwise,

from its activities, except that the Corporation shall be authorized to pay reasonable compensation for services rendered and to make payments in furtherance of the purposes set forth in Paragraph 3 hereof.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

The Corporation shall not carry on any activity not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation,

contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

8. If the Corporation is to be dissolved, the Board of Trustees shall, after paying or making provision for the payment of all of the liabilities of the Corporation, dispose of all the assets of the Corporation conclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Trustees shall determine. Any of such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of

the Corporation is then located, exclusively
for such purposes or to such organization
or organizations and granted exclusively
for such purposes.
